Review of March minutes. **Motion** to approve minutes **approved** (Kleeman/Bernhard/unanimous).

Treasurer's report. Motion to approve financial report as presented approved (Kleeman/Connors/unanimous).

Short presentation by Sacramento Sports Commission representatives Mike Sophia and Brad Hillard. Update on events involving the Sports Commission: 25-31 July 2016 National Junior Olympics at Sac State; 2016 NCAA XC West Region Meet at Haggen Oaks Golf Course; 22-25 June 2017 USATF National USATF Outdoor Champs to be announced shortly; 2018 NCAA West Regional T&F at Sac State; and possible bid for 2018 National USATF Masters Outdoor Championships and future NCAA events.

Proposal presented by Shrock to fund Assoc. Master's T&F athletes to attend

national/international outdoor T&F Champs. Grant would be to fund Master's athletes who rank the top 5 in the US, and/or top 10 in the world and who demonstrate financial need. Similar application to the Olympic Training grant (click here), and open 15 June, closing 30 June with a 3-person selection committee to be named. Friendly amendment accepted from Ann Gerhardt to make this a one year pilot for evaluation in Sept. before renewing for future. (Bartholomew/Bernhard/unanimous)

Gender identity procedure review (refer to full text in Committee Reports)-Shrock

Shrock reviewed procedure provided by USATF legal counsel. Don Collins concerned that USATF official acting as meet referee would have to make decision. Kleeman/Thompson noted that Referee has to only read gender designation on provided legal document (drivers license/birth certificate) to make determination. Collins invited to send concerns to USATF legal counsel.

#### Youth Coach ID badge implementation for 2017 season – Sneed

With the concern of the Youth Committee that only screened individuals are on the field during an event, the Youth Committee is exploring the creation of ID badges, updated annually with photo and hologram to assure only those LiveScan, SafeSport cleared are on the field during youth events.

Shirley Connors voiced a concern on who was going to enforce, and response was this is still in the works. Youth Committee to explore further for 2017 implementation after JO's in August.

## CTRN follow-up- Calvin

Cynci reported positive discussions with publisher Larry Eder of 2 print (*May/June print edition supplied at meeting*) and 4 electronic editions of the CTRN per year. Unlimited space in electronic editions for committee reports, meeting minutes, and any info we would want to include. It is still on us to provide content and photos. Gerhardt reminded group we need to include RaceWalk.
