
Exercise for Teaching Officials to be the Recorder

To make this exercise more realistic, print the red cards onto red paper, and print the tally sheets onto white paper. Have a Runner and Chief Judge during the exercise (it can be the same person – the instructor).

Give each practicing Recorder a Race Walk Judging Summary Sheet and pencil. This is a women's 10K race starting at 7:20 a.m.

Arrange the red cards in sequence by time (note the letters in the upper left-hand corner of each card). Give the red cards to the Recorder(s) in order by time.

Note that the red card at 8:15 a.m. (F* in the upper right-hand corner) is not signed. The Recorder should have the Runner return the card to Judge #6. As it turns out in this exercise, the judge decided not to write a red card; it was handed in by mistake.

When three red cards have been received for a competitor, a red mark goes on the red-card posting board, then have the Recorder alert the Runner to take those red cards to the Chief Judge for verification. Have the Chief Judge write the time at which the Competitor is given the red paddle and notified of his/her disqualification on the front of one of the red cards, and have the Runner return the three red cards to the Recorder, at which time the Recorder enters this time on the Summary Sheet.

Give the Recorders the times that the Chief Judge gave red paddles and notified the competitors of their disqualifications:

8:34 to Competitor #567

8:46 to Competitor #622

8:55 to Competitor #8:55.

After all the red cards have been delivered to Recorders, have the Recorders compare their Summary Sheets with the one marked "EXAMPLE – DURING THE RACE – RED CARDS ONLY."

Then have the Recorder enter the data from the Judges' Tally Sheets.

Note that Tally Sheet for Judge #8 was not signed. Have the Recorder give it back to the Runner to take to that Judge for signature.

Have the Recorders compare their Summary Sheets with the one marked "EXAMPLE – COMPLETED SHEET."

Note that the Tally Sheet for Judge #8 shows a Yellow Paddle for Competitor #622 at 8:47, but the Chief Judge notified the Competitor that she was disqualified at 8:46. This discrepancy could be because Judge #8 did not synchronize her watch with that of the Chief Judge. Alternatively, Judge #8 wrote down the wrong time.

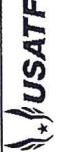
