The races will be run in the order below. Some races may be combined depending on the number of runners. Awards will be given to the top three finishers in each division

Age Division	Distance	Age (as of 12/31/2019)
Group 1	2K (1.25miles)	8 and under
Group 2	3K (1.87miles)	9-10
Group 3	3K (1.87miles)	11-12
Group 4	4K (2.5miles)	13-14
Group 5+	5K (3.1miles)	15-18

**Directions:**

From Sacramento or the East Bay: Get to 880. Take the Dumbarton Bridge (84 West). Turn right onto Marsh Road to enter Bayfront Park. Continue until the road ends.

From the Bay Area: Get to 101 heading towards Menlo Park. Take the Marsh Road exit, heading east. Cross over Bayfront Expressway into Bayfront Park. Continue until the road ends.

Course: The course has gravel, dirt, rocks and asphalt with gentle hills. No spikes allowed.

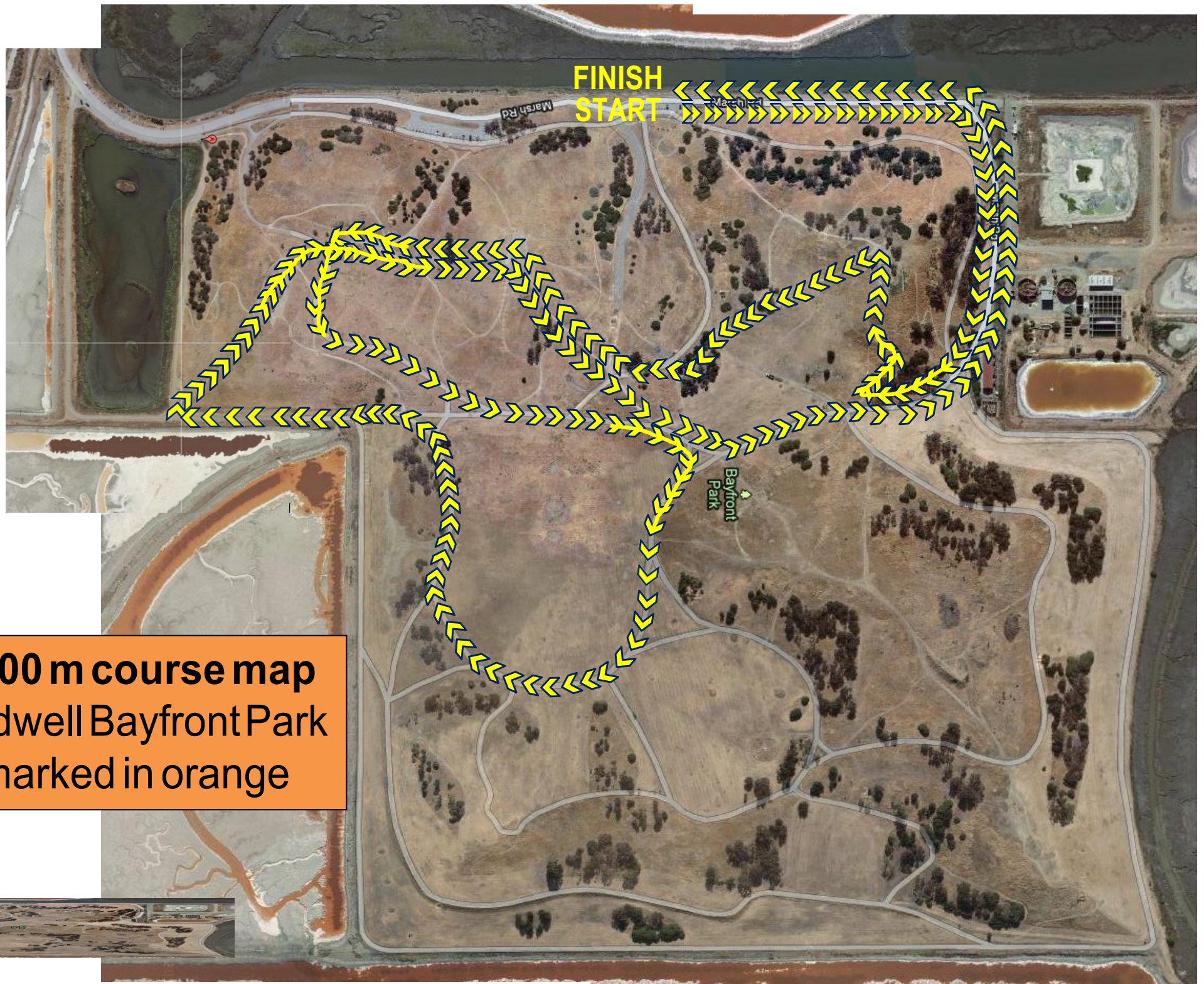

marked in green





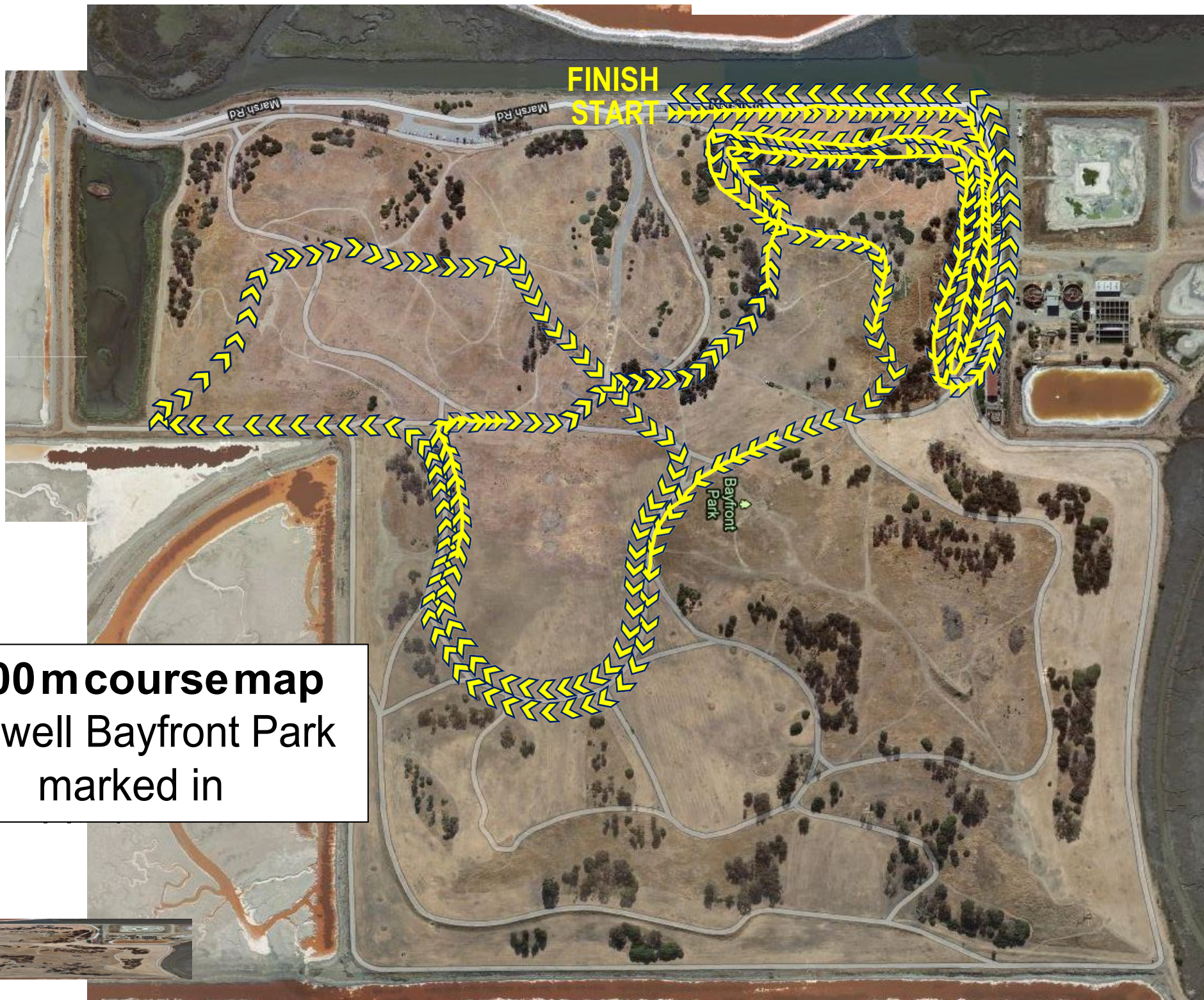
