 - Cori reviewed the minutes from the previous meeting, highlighting the key updates and corrections.
 - **Action:** Motion to approve – Phil Leake, Second – Tony Gates: the minutes as reviewed. Motion passed unanimously.
- 7:40 – 7:47pm: CenCal's decision to merge with Pacific Association – Irene
 - Irene Herman announced that CenCal formally decided to merge with the Pacific Association, effective January 1, 2025.
 - Key areas of discussion included:
 - Transitioning member data and administrative workflows.
 - Coordination with CenCal leadership to manage the integration seamlessly.
 - **Action:** Irene to lead a working group to address transition logistics, with a focus on minimizing disruption for members.
 - **Motion** by Irene to accept CenCal as part of the Pacific Association.; No abstentions and no opposition; Motion carries.
- 7:48 – 8:05pm: Treasurer's Report-Jason & John-2025 Finalize budget-Action item
 - Jason and John presented the finalized 2025 budget, emphasizing strong financial performance and future planning.
 - Highlights included:
 - Investments yielding higher-than-expected returns, with a projected surplus of \$15,000 for the year.
 - Continued funding for youth travel grants and expanded event budgets.
 - Concerns over rising operational costs were addressed with targeted

cuts in non-essential areas.
