## What is Our Vision? (Excerpts from "Visionary Leadership" by Burt Nanus)

A vision is a realistic, credible, attractive future for your organization. It is your articulation of a destination toward which your organization should aim, a future that in important ways is better, more successful, or more desirable for your organization than is the present.

Vision always deals with the future. Indeed, vision is where tomorrow begins, for it expresses what you and others who share the vision will be working hard to create.

A vision is only an idea or an image of a more desirable future for the organization, but the right vision is an idea so energizing that it in effect jump-starts the future by calling forth the skills, talents and resources to make it happen.

Vision is a signpost pointing the way for all who need to understand what the organization is and where it intends to go. Sooner or later, the time will come when an organization needs redirection or perhaps a complete transformation, and then the first step should always be a new vision, a wake-up call to everyone involved with the organization that fundamental change is needed and is on the way.

Selecting and articulating the right vision, this powerful idea, is the toughest task and the truest test of great leadership. When this is achieved, the organization is already well on it's way to realization of the dream.

• The right vision attracts commitment and energizes people. People seem to need and want something they can commit to, a significant challenge worthy of their best efforts. People are willing, even eager, to commit voluntarily and completely to something truly worthwhile, something that will make life better for others, or that represents a significant improvement for their community or country, or that enables their own organization to grow and progress.



 Vision also establishes a standard of excellence which provides the measure by which all stakeholders can evaluate their worth to the organization and by which outsiders can measure the organization's worth to the larger society Mission-Why we do what we do. Values-How we do what we do. Vision- the Playbook of what we do.

Once people buy into the vision, they possess the authority, that is, they are empowered, to take actions that advance the vision, knowing that such actions will be highly valued and considered legitimate and productive by all those who share the dream.

A vision has no power to inspire or energize people and no ability to set a new standard or attract commitment unless it offers a view of the future that is clearly and demonstrably better for the organization, for the people of the organization and /or for the society within which the organization operates. The vision, in short, must be manifestly desirable, a bold and worthy challenge for those who accept it. So, any vision is a mental model of a desirable and idealistic future for the organization.

How does this apply to Officials? We provide unbiased, impartial judgement at all track and field, cross country, racewalk and LDR meets. We make sure the flow of the meet is on schedule. We are also ambassadors of the sport in that we come in contact with athletes, coaches, educators and fans. If things go wrong (and sometimes they do), we become the adjudicators of such fairness. WE assist the promotion of the sport. We cannot do this if we do not share a common vision. It initially stems from our common love of the sport. We all have our reasons for becoming officials. Our vision is to not only accepting of officials from all walks of life, but to promote the sport, increase the number of active officials, train and retain these certified officials to meet the needs of a growing track and field community.

We accomplish this by providing continual training, helping new and experienced officials through the certification process and maintaining their certification, provide new opportunities to officiate, help officials upgrade their level of certification and recognize those individuals who perform exceptionally. Our existence is marked by these values (vision). They can be measured as our officials are well respected within USATF and are one of (if not the largest) in number of officials and our members are often chosen to work major meets and National Championships. The growth of indoor meets in our region is another example as the number of meets for next season have increased and NCAA Conference Championships will be held there in 2026.

In summary, our Officials are some of the best in the country. But, we will not and should not rest on our laurels. We should be constantly working to be the best we can be and striving to promote the sport we love. **This is our vision.**

## **Certification Chair's Report**

Remember to stay 3-way compliant; It is necessary for keeping certification valid: Is your USATF membership current? Please check on your USATF connect (sport80) profile and renew if necessary. If you did not have an auto-renewal or multi-year USATF membership and did not renew the membership, it has expired at the end of 2023. To stay 3-way compliant, the membership needs to be renewed. Start at the USATF connect (Sport80) profile page membership tab. The other 2 aspects of the 3-way compliance are the Safesport training and background check. If you are not 3-way compliant, your certification is not valid. For many of us who first started with the current Safesport training curriculum introduced back in 2019, we are due for the full core training instead of the 3 refreshers. This core training can take up to 4 hours. Be prepared to set aside that time.

#### **Certification changes:**

- The EDM/EDR discipline has gone from grade to level. The total of previous grade levels of EDM and EDR determine the new level. Sum of 4 is master, 3 is national, 2 or 1 is association. e.g. EDM grade2 and EDR grade 2 is Master. EDR grade1 only is association level.
- The Para discipline is changing from grade to level but details are still TBD
- NOC has approved pins and certificates for Emeritus officials. NOC is confirming the list now. Once the list is confirmed, the pins and certificates will be mailed to the certification chairs (like the badges) for distribution by the cert chairs.

#### **USATF Championship applications will open Sep 15, close Oct 15:**

- Application form/invitation expected to be posted on NOC.mach2k.net
- Like in the last few years, resume expected to be limited to maximum 16 meets over the last 4 years and application limited to 4 events per meet applied
- Masters meets are open to all certification levels
- With the change that was approved last year to the governance regulation, now JO is required to give preference to National and master level officials. However, if an event does not get enough applications from national and master officials, the committee may accept association or apprentice officials. Selections are expected to be announced by Jan 24, 2026
- As before, the top 3 USATF meets and the WA meets are limited to national/master level – open Indoor/Outdoor, U20, WA U20, WMA. Selections for the top 3 USATF meets will be announced at the end of the USATF annual meeting (Dec 6, 2025). Emails and posting may go out the following week
- The selections for the WA U20 meet will probably be sometime in January 2026.
   The WMA IVO (international voluntary official) application process and selection is TBD.

## **CIF Officials Registration**

This is a new wrinkle in officiating at the HS level. All PAUSATF Officials who choose to officiate high school meets in California will have to comply with this new requirement from the California Interscholastic Federation (CIF).



Mike Brown (PAUSATF Youth Committee's HS Liaison) has gotten clarification from CIF on this and the particulars on getting registered. **From Mike:** Attached is the information I received from Brian Seymour, State CIF official who oversees officials throughout the state. Even though some of us who been CIF certified through CTSA and NFHS, we will now have to do additional requirements per the CIF. We will be required to do a background check, and probably Safe Sport, as part of our individual certification process. This year is a pilot year, but will be required for the 2026-2027 school year.

#### Registration

To become a CIF Certified official, you need to have an Arbiter Sports account (<a href="https://app.arbitersports.com">https://app.arbitersports.com</a> or if you are a 1st time registrant <a href="https://app.arbitersports.com">Arbiter - News & Announcements</a> in order to access the CIF registration process.

If you already have an Arbiter account, try the following:

- 1. Make sure you are on the Home page and at the top it should read: Dashboard Schedule Payments Blocks **Eligibility** Lists Settings
- 2. Click on Eligibility. You should then see Eligibility and Registration.
- 3. Click on Registration and hopefully the CIF Registration will populate to become an official.

Cost for the registration, background check and access to the test is \$29.00.

If you are a USATF member, I am continuing to check with the CIF and Arbiter to see if we can share our background check (may not happen) and our Safe Sport information with Arbiter (may happen).

#### **Testing**

I am, so far, two way compliant in this process and I'm waiting to gain access to the NFHS test that is required as part of the eligibility process. There will be 70-75 questions and an official will need to pass with 70%. I'm in the process of working with our State Association about what will be required. The test will most likely populate once the NFHS Rule and Case Books are available. The negative about this process is that an individual is not currently required to go through a training program to show that they know how to officiate a meet/event. However, we will continue to require the training that we have always done in order for our members to be certified per CIF requirements for our Association.

Once a person becomes CIF certified, they will also have access to Arbiter's insurance (much like what is provided by NFHS membership through Dissenger-Reed Insurance). When officiating at a high school XC or track meet, this insurance is more readily accepted by the schools/districts than the USATF insurance since almost all schools/districts use Arbiter to pay officials. If this is the case, then there will not be a need to also join NFHS Officials through DragonFly unless you choose to do so.
